Expert Witness Experience

Fees for expert witness services are as follows:

1. Retainer of \$650.00

This will allow me to do a summary review of the materials that you send me and to advise you of the merit of the matter at hand. I will typically review my opinion with you by phone.

2. Hourly fee of \$565.00

This hourly fee is due in advance as time spent progresses and at your direction based on an agreed estimate of time to be spent. This will include review of materials in detail, formulation of expert opinion, preparation for settlement or trial and advice relative to dental claims as you feel necessary. Should I spend time in excess of the estimate I will advise and bill accordingly. This may occur if there is a pressing schedule to deliver opinions or reports or if I find myself in the middle of an agreed project. I will return any funds representing unused time within 14 days.

- 3. Court appearances will be billed at the rate of \$5000.00 per day or part of a day plus travel expenses if the calendar permits me to appear without disrupting my operating schedule. (I am typically not operating on Fridays.) Should I be required to appear at another time, I would negotiate fee and travel expenses appropriate to the circumstances. If I must close my practice in order to appear at a given time, appropriate charges of \$7200 per day will be made to compensate. Travel expenses would be billed additionally.
- 4. Depositions will be scheduled at my office during my normal office hours when possible and will be billed at the normal hourly rate of \$565.00 per hour. This time must be reserved at least two weeks in advance and payment for the time reserved is due at least two weeks prior to the deposition. This fee is non-refundable unless there is one full week's notice given for a change in schedule.
- 5. All payment is due in advance (2 weeks in advance of court appearance). Any payment in excess of time utilized will be refunded within 2 weeks.
- 6. This agreement is made between Sander White DDS and the attorney who engages me. I specifically will not engage in this arrangement with the attorney's client personally.
- 7. These fees and the payment schedule shall govern and no deviance for convenience or courtesy shall be construed as substituting for or changing this agreement.
